Additives are cleared according to FDA 21 CFR Part 178 (Indirect food additives), are generally recognised as safe (GRAS), are prior-sanctioned food ingredients, or are cleared on basis of regulations for food additives of before 1958.

Test conditions for overall migration were OM0 (30 min at 40 °C) Food simulants used for overall migration were 50 % ethanol (simulant D1) and 3 % acetic acid (simulant B). Compliance with specific migration limits, and other restrictions, has been documented through testing, calculation or simulation.
