**Regulation (EU) No 10/2011** The monomers and additives used in the manufacture of this product are listed in Annex I to Regulation (EU) No 10/2011 of the European Parliament and of the Council of 14 January 2011 on plastic materials and articles intended to come into contact with food, as amended.

Vikan A/S does not use multi-layer materials or articles with a functional barrier.

**General**

The product is suitable for repeated use under the conditions specified in this Declaration of Compliance. Reuse does not affect the product's compliance with applicable food contact regulations, provided it remains intact, undamaged, and is cleaned appropriately between uses.
